## Dear Tollerton Resident,

We're putting together a Neighbourhood Plan for Tollerton and need your help in making sure that the Plan reflects the wishes of people like you who live here.

## Why does Tollerton need a Neighbourhood Plan?

Currently Tollerton's residents have little influence on local planning issues, such as where expansion should take place and the type of development that should be undertaken – these decisions are made by Rushcliffe Borough Council.

Tollerton residents told us that they would like to have more of a say in these decisions. Producing a Neighbourhood Plan for the parish will give us all the opportunity to have a say on how our village should develop and importantly what facilities and infrastructure will be needed across Tollerton.

## Will producing our own Plan really make a difference?

Most definitely yes – if approved (by Tollerton residents through a referendum), the Tollerton Neighbourhood Plan will have legal force. Developers and local authority planners will have to take notice of it.

**But we need to have strong local evidence behind it based on your views** - and that means lots of questions. So please grab a coffee or glass of wine and work your way through the survey to help your village.

Without a Neighbourhood Plan, we will continue to have little control over any development that takes place and may receive less funding from those developments. Our Neighbourhood Plan must comply with the Rushcliffe Borough Council's Local Plan and, in order to do that, it is inevitable that some new development will occur within Tollerton. Having a Tollerton Neighbourhood Plan will help us ensure that the location, character and nature of that development is suitable for the village and meets the needs of current and future residents.

## Please get involved!

Developing a plan requires close consultation with residents, businesses and other local organisations. This survey is key, as its results will help determine the overall direction of our plan, and so it is very important that you, your family and your neighbours take this opportunity to make your views known.

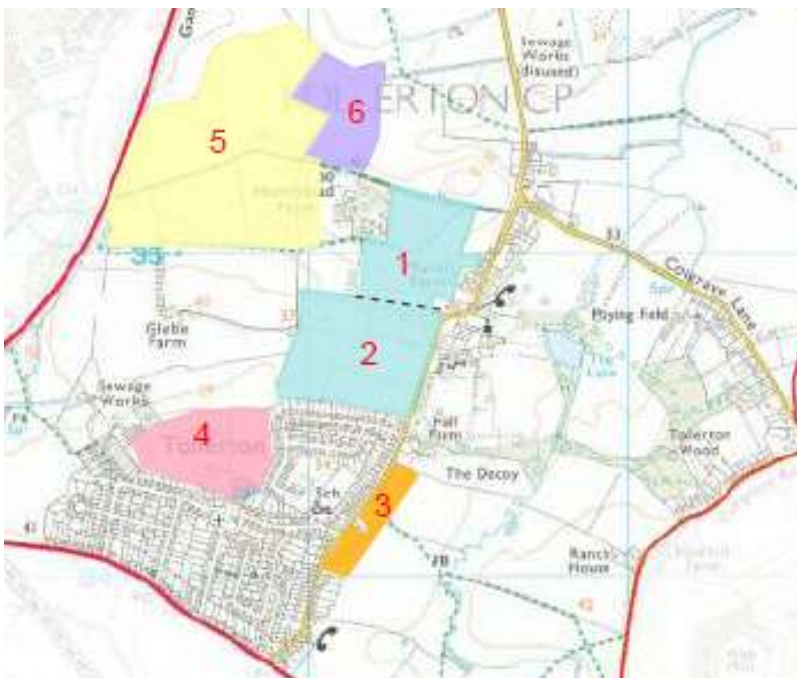
